


# BEHR® FAST DRYING WATER-BASED WOOD STAIN

WHERE TO USE: Properly prepared interior, smooth unfinished, unsealed or stripped wood surfaces, including floors.

# **SURFACE PREPARATION**† (Proper surface preparation is required)

- Surface must be dry, clean, and free of dirt, grease, glue, and existing coatings before staining.
- Sand the wood in the direction of the grain using fine-grit sandpaper (#150) until smooth.
- Remove all sanding dust.
- To ensure uniform acceptance of stain color and beautiful results, pretreat the wood with BEHR® Water-Based Pre-Stain Wood Conditioner following label directions.

# PRODUCT PREPARATION AND COLOR TESTING

- Stir stain thoroughly before and occasionally during use.
  Do not thin.
- Always test stain on an inconspicuous area of the wood to verify desired color.

#### STAIN APPLICATION

- Apply stain in the direction of the grain with a brush or clean cloth.
- Allow the stain to penetrate 2-3 minutes to achieve desired color.
  The more time the stain is allowed to penetrate, the richer and darker the color will be.
- Remove stain that has not absorbed into the wood with a clean cloth. Wipe in the direction of the grain, while blending light and dark areas to obtain uniform color. Do not allow stain that has not penetrated into the wood to dry on the wood surface.
- To darken the color, apply a second coat after 1 hour, repeating directions above. Do not sand between coats of stain.

## **CLEAR FINISH APPLICATION**

- Allow stain to dry for a minimum of 1 hour (dry time may be extended due to high humidity, low temperatures, or inadequate ventilation).
- Complete your project by applying a BEHR Clear Protective Finish, following label directions.
- Recommended finishes include BEHR Fast-Drying Water-Based Polyurethane or BEHR Water-Based Spar Urethane. Slight ambering may occur when these clear finishes are applied over light-colored stains. Always spot test on an inconspicuous area to ensure satisfactory results.
