## **PREPARATION**

(Proper surface preparation is required.) Allow new stucco, plaster and masonry to cure for 30 days. Clean: For interior and exterior surfaces, remove dirt, oil and grease stains with a concrete and masonry degreaser and cleaner. Remove mildew stains with a mildew stain removing product. Remove all loose and peeling paint; scuff sand glossy surfaces; caulk; repair imperfections and sand smooth.

For exterior surfaces, powerwash to remove chalk. Etch galvanized metal with a concrete and masonry cleaner and etcher. Follow all label instructions. **PRIME:** For uncoated exterior surfaces, use a product such as BEHR PREMIUM PLUS® NO. 436 Exterior Multi-Surface Primer & Sealer. For all uncoated interior surfaces, use a product such as BEHR PREMIUM PLUS No. 75 All-In-One Primer & Sealer.

## APPLICATION

DO NOT THIN. Stir before and during application. When working with more than one can of the same product, intermix to ensure color uniformity. Use adequate ventilation during application & drying process. Certain colors may require more than one coat to achieve complete hide and coverage. Use product when air and surface temperature are 40-90°F (4-32°C). Apply a thin coat using a high quality china bristle brush, 1/4-3/8" nap roller or an airless sprayer (.013-.015" spray tip, 60 mesh filter).

#### **DRY TIME**

Longer dry time required in cooler temperatures and higher humidity or with darker colors. Wait at least 7 days before rinsing or cleaning the surface with a mild, non-abrasive detergent.
